#### **SECRETARY'S REPORT:**

Ms. Durbin presented the public and executive session minutes of the Council meetings held on October 13 and the minutes of the Communications Committee meeting held on October 26 and recommended approval.

(R) Ms. Durbin moved, Ms. White seconded, that the public and executive session minutes of the Council meetings held on October 13 and the minutes of the Communications Committee meeting held on October 26 be approved. The motion carried. (7-0-0)

## **OLD BUSINESS:**

Update from Council Communications Committee on plans to redesign website: Ms. Durbin reported that responses to the request for proposals for the redesign of the website were under review and additional information has been requested from the prospective designers.

Update from Council Capital Improvements Committee on Village Center improvements: Mr. Mertens reported that he attended a meeting with the staff and Mike Poness and Art Robinson from WMCRP to discuss the scope of work for the improvements to the Village Center. Mike will prepare plans and design options to be reviewed by the Capital Improvements Committee at its meeting on January 12 at 4:00 p.m. Mr. Mertens also stated that the street lighting report from the lighting consultant and the landscaping contract will be discussed at the December meeting of the Capital Improvements Committee.

Mr. Mansfield noted that the consultant has recommended cleaning the lenses in the street light fixtures and maintaining a schedule for replacing all Village street light bulbs over a five-year period instead of waiting for a bulb to burn out. The staff is in the process of implementing these two recommendations.
