## General Information:

- Currently, there is no fee for exhibiting at Friendship Gallery.
- \* The date you request may not be available. If your proposal is accepted, we will offer the first available date .
- \* Art Delivery and installation is generally on a Sunday, between 11 a.m. and noon. The show then opens on the following Monday.
- \* Art Pick up is generally at noon on the Sunday after the show closes.
- \* A reception is generally one week after installation, on Sunday from 11:30 to 1 p.m., and is the responsibility of artists in the show.
- \* The Village Center is not able to store artwork. Artwork must be collected on the designated Pick Up date.
- \* If applicable, the group of artists would designate a guest curator.
- \* The artist or group of artists would provide a Program for visitors to the exhibit. The program should list artists and their work numbered in the position they hold in the exhibit, a bio of each artist, basic information about the artwork: title, dimension, price or Not For Sale.
- \* Sales of artwork are handled by the Village Center Front Desk staff and payment is by check or cash only.
- \* Friendship Heights Village Center requires a 20 percent commission on all art sales.
- \* Artists are responsible for reporting and paying sales tax collected on individual sales.
- \* The gallery uses a rod and hook system that requires all artwork be wired so as not to flop.
- \* The gallery cannot sustain free-standing sculpture. Wall hanging sculpture is acceptable.
- \* Artists are responsible for installing the exhibit. No Village staff is available to install.
- \* No adhesives may be affixed to the walls of the exhibit area.
- \* Tags can be safely affixed to the artwork from behind and on the frame or canvas.
- \* Artwork should be numbered and referenced on the Program for the convenience of visitors.
- \* Only original artwork can be exhibited. Giclee prints or prints of paintings and watercolors are not permitted.
