### Direction and name of impacted road and cross street names

- Site #1: The median at River Rd (MD 190) between Wilson Ln and Winston Dr
  - o Southbound left lane closure
- Sites #2/#3: NW and SE sides of intersection of River Rd (MD 190) and Goldsboro Rd (MD 614)
  - Northbound (straight) right lane closure
  - Southbound (straight) right lane closure
  - o Eastbound (straight) right lane, shoulder, and ramp closure
  - Westbound shoulder and ramp closure
  - Sidewalk and temporary bus stop closures on NW and SW sides of intersection
  - Detours (<u>trucks only</u>):
    - Southbound trucks approaching intersection of River Rd (MD 190) and Goldsboro Rd (MD 614) from southwest will be detoured straight along Goldsboro Rd (MD 614), right onto Bradley Blvd (MD 191), right onto Wisconsin Ave NW (MD 355), right onto Western Ave, and straight back

- to River Rd (MD 190)
- Northbound trucks approaching intersection of River Rd (MD 190) and Goldsboro Rd (MD 614) from northeast will be detoured straight along Goldsboro Rd (MD 614), left onto Massachusetts Ave (MD 396), left onto Western Ave, and straight back to River Rd (MD 190)
- Site #4: SW side of intersection of River Rd (MD 190) and Western Ave
  - Southbound (straight) right lane closure
  - o Sidewalk closure on SW side of intersection
  - o Note- Site #4 will only be used from time to time during planned work period

### Description of the work

Install remote control valve on existing natural gas transmission line in the median of River Rd (MD 190). Remove valve in the northern lane of River Rd (MD 190) at the Goldsboro Rd (MD 614) intersection. Replace tee in the southern lane of River Rd (MD 190) at the Goldsboro Rd (MD 614) intersection. Access and use natural gas drawdown compressor across the valve in the sidewalk along River Rd (MD 190) at the Western Ave intersection.
