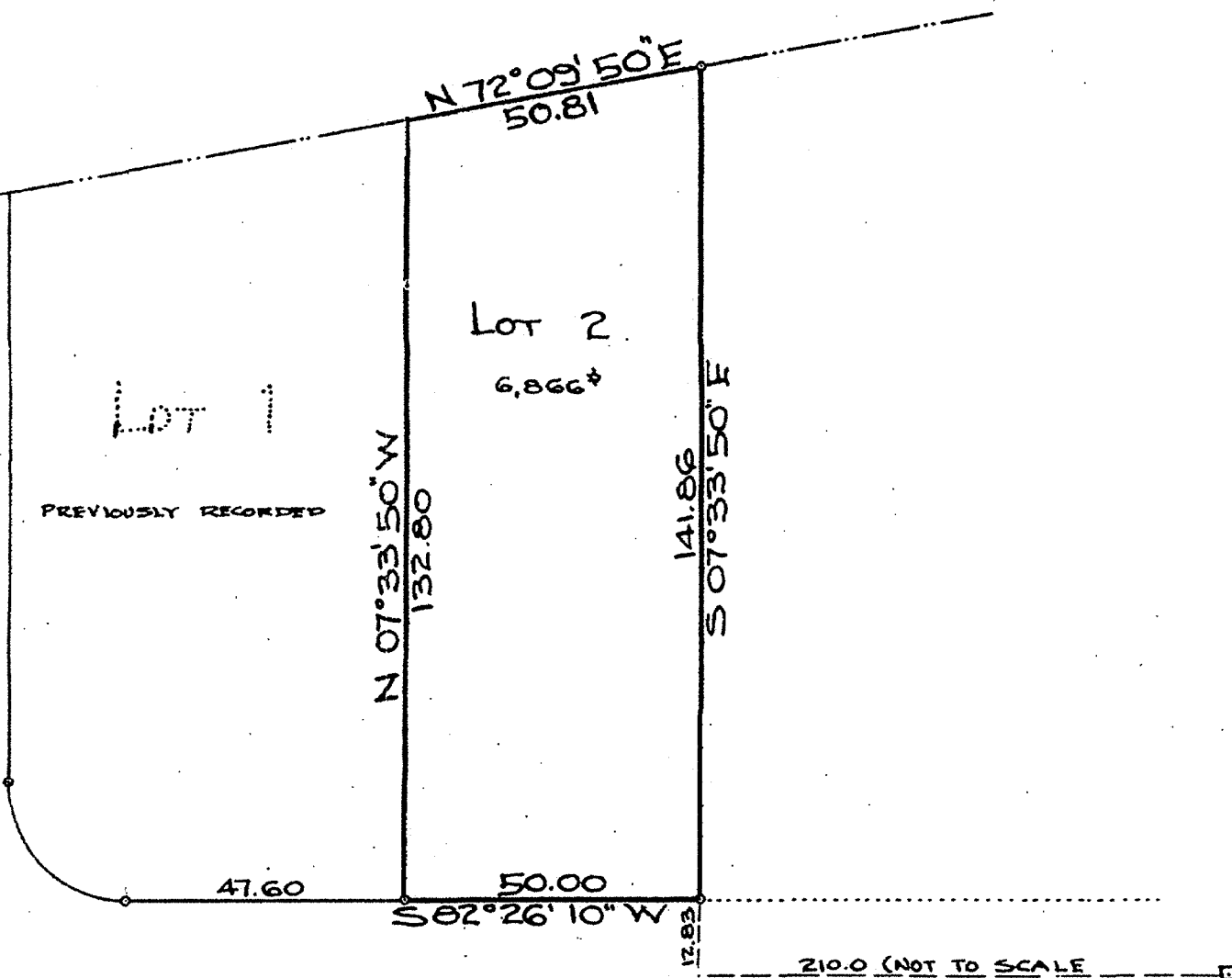
LOT 2, BLOCK C
