Applications for mail-in ballots can be downloaded from the Village website. A completed application must be *received by* postal mail or by email no later than 5:00 p.m. **Monday, April 28, 2025**. If using postal mail, mail to:

If using email, print your completed application, sign it and scan or take a photo of the signed application and email it to www.comd.org (please include "mail-in ballot" in the subject line).

In-person voting will take place at the Village Center, 4433 South Park Avenue, Chevy Chase, MD, from 7:00 a.m. to 8:00 p.m. on Monday, May 12, 2025. Note that a limited number of voters will be allowed in the polling place at one time. If you received a mail-in ballot, **you must vote that ballot**. You may bring your mail-in ballot to the drop box at the Village Center before or during Election Day.

On the Ballot

Eight candidates for the Village Council are running for seven seats. All candidates were asked to write a statement describing why they are running for this office and what makes them qualified to serve. The League does not make any edits or corrections to the text that was submitted.

Candidate Forum

A forum for the candidates will be held on **May 5**, **2025**, at 6:30 pm at the Village Center and will be live streamed. As a lifelong resident of Montgomery County and a dedicated member of the Friendship Heights community for 23 years, my roots in our neighborhood run deep.
