Friendship Heights Village Council Award to David Rabin for End-of-Life Preparation Programs under the New Initiatives Project

Under this Award, two formal presentations were given by Dixcy Bosley, RN, MSN, FNP, with long-term life experience providing end-of-life care. She is also a Nurse Manager of the Iona House Aging and Care Giving Team. The first of her End-of-Life presentations was held on Sept. 30 via Zoom for 55 registrants. The second presentation about End-of-Life documents was in person at the Friendship Heights Village Center on Oct. 29. Document copies were available for the 58 attendees.

Following these presentations, Friendship Heights residents were offered end-of-life private consultations at IONA Senior Services. Seven sessions were provided. The programs and sessions were scheduled, coordinated and managed by Friendship Heights Neighbors Network.
